

TEENS CHARGED W/DISTRIBUTING Child PORN ON FB

COPENHAGEN 1/15/18– According *Reuters*, Danish police charged 1,004 children and young people for sharing video clips of two 15-year-olds having sex, following a tip-off from Facebook.

They said it could constitute distribution of child pornography, although the age of consent in Denmark is 15.

The two video clips were shared through Facebook's Messenger chat-platform in the Fall of 2017. Facebook is obligated to advise the U.S. authorities about it, which they did. The tip-off was then passed on to Denmark via Interpol. Most of the young people who were charged shared the videos only a few times, but some others shared the clip several hundred times, police said.

Don't let the fact that it was the police in Denmark who charged the FB users throw you off. Think about that last statement... *Most of the young people who were charged shared the videos only a few times, but some others shared the clip several hundred times.*

Think about the "stars" of these two clips. They are 15 year olds whose intimate acts have been shared "several hundred times." With facial recognition software ever-present, these children may have a mark against them for every job or college application that does a background check. Imagine not being offered a position/promotion because what you did as a teen has the potential to embarrass the institution.

Consider this as well, if the 1004 young people were convicted of distributing child pornography **in the US**, they would have to register as SEX OFFENDERS for the rest of their lives. Adolescent brains aren't even CAPABLE of imagining such a scenario in the time it takes to "like and share" a video.

Parents, this is worthy of a discussion, don't you think?

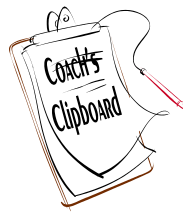
“There’s teams dedicated to it. I mean, we’re talking, we’re talking three or four... at least, three or four hundred people... Yes, they’re paid to look at [nudies].”

Pranay Singh, a Direct Messaging Engineer for Twitter corroborated Haynes claims in a meeting with a Project Veritas journalist on January 5, 2018: “Everything you send is stored on my server... So all your sex messages and you, like, [your nudies] are on my server now... All your illegitimate wives and, like, all the girls you’ve been [having sex] with, they’re are on my server now... I’m going to send it to your wife, she’s going use it in your divorce.”

“So, what happens is like, you like, write something or post pictures on line, they never go away... Because even after you send them, people are like analyzing them, to see what you are interested in, to see what you are talking about. And they [Twitter & others] sell that data.”

They sell it to advertisers who create a “virtual profile” of you. And one of the things those advertisers want to know is that the profile they are creating and marketing, is a real person, so according to Twitter software expert Mihai Florea, “...we have to prove it was you, and that’s why [we ask you to supply an] email address, or like a cookie or something that can track you.” Florea continues, saying, “You’re paying for the right to use our website with your data, basically.”

Another “teaching opportunity” we wish we never had!



COACHING EXERCISE!

Remember Dopamine engages the mechanism which constructs the neural networks that will be hardwired in an adult. Using a network over and over again is what will hardwire it in adulthood. If you want to reroute traffic for a pattern that has already been constructed, you can't use punishment alone. Taking away a privilege does NOTHING to make that network less of a superhighway. To change where an adolescent’s brain wants to go, requires constructing another pathway for electrical impulses to run on.

I'm not saying there shouldn't be punishment — that is necessary to establish parental authority to guide him/her. BUT if you **only** punish, the road to the behavior you want to discourage will never get overgrown. Finding something **else** that brings great joy, honor, or admiration is key.

What that means as a parent is you have to find out what motivates **your** child — and then be creative about tying that desire to behaviors.

An example might be: *You are still losing a privilege for sneaking onto the wifi after I shut it off, but I want to help you work on this. So, moving forward, every time I catch you doing something else to master that impulse to play video games, I'm going to add fifty cents to a fund [for whatever the goal is which would motivate your child.]*
